DATA SECURITY AND PRIVACY POLICY**

This Privacy and Data Security Policy ("Privacy and Security Policy") regulates the procedures and principles regarding how the confidentiality and security of personal data processed by **TAMEK SAGRA GRUP GIDA ÜRETİM A.Ş.** (will be referred to as "**COMPANY**" or "**TAMEK SAGRA**") is ensured.

For legal reasons such as the establishment or performance of the contract specified in Articles 5 and 6 of the KVK Law, legitimate interest, legal obligation, establishment, exercise or protection of a right, within the scope of your visit to our website, your personal data is collected through cookies, which are technical communication files, due to your visit to our website in accordance with the data processing conditions in the Law.

### 5. Clarification and Rights of Personal Data Subjects

We inform you, the personal data subject, that you have the following rights in accordance with Article 11 of the Law No.6698: Learning whether your personal data is processed or not, If your personal data has been processed, requesting information about it, Learning the purpose of the processing of your personal data and whether these personal data are used in compliance with the purpose, Knowing the third parties to whom your personal data is transferred in the country, Requesting correction of your personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to the third parties to whom your personal data has been transferred, Requesting the deletion or disposal of personal data in the event that the reasons requiring its processing cease to exist despite the fact that it has been processed in accordance with the Law and other relevant law provisions, and requesting the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred, Objecting to a result against you by analyzing the processed data exclusively through automated systems, Claiming compensation for the damage arising from the unlawful processing of your personal data.

You can submit your applications regarding your rights listed above by filling out the Data Subject Application Form, which you can access on our website on ([www.tameksagra.com](http://www.tameksagra.com)), or with another written document with the same content, to the address of “**TAMEK SAGRA**” stated below. Depending on the nature of your request, your applications will be concluded free of charge as soon as possible and within thirty days at the latest, however, if the process requires an additional cost, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Board.
