

In accordance with the relevant provisions of the Law on the Protection of Personal Data No. 6698 (KVKK), this clarification text is prepared by **TAMEK GRUP GIDA ÜRETİM A.Ş.** (will be referred to as "**COMPANY**" or "**TAMEK**") as Data Controller within the framework of the Communiqué on the General Illumination Text and the Procedures and Principles to be Followed in Fulfilling the Obligation of Illumination within the scope of the Law on the Protection of Personal Data.

In order to ensure the security of the building, video recordings are made through the security cameras located in the entrance doors, building exterior, office floors, building production and packaging areas, cafeteria, parking lot, visitor waiting area, security booth in our service building. Registration procedures are supervised by the Information Systems Department and the Human Resources Department.

It is processed automatically based on the legal reasons "Obligatory for the Data Controller to fulfill their legal obligation" and "Data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject." in Article 5 of the Law on Protection of Personal Data No. 6698. The personal data in question may be transferred to the judicial authorities or the relevant law enforcement authorities upon request to resolve legal disputes or in accordance with the relevant legislation.

We inform you, the personal data subject, that you have the following rights in accordance with Article 11 of the Law: Learning whether your personal data is processed or not, If your personal data has been processed, requesting information about it, Learning the purpose of the processing of your personal data and whether these personal data are used in compliance with the purpose, Knowing the third parties to whom your personal data is transferred in the country, Requesting correction of your personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to the third parties to whom your personal data in the event that the reasons requiring its processing cease to exist despite the fact that it has been processed in accordance with the Law and other relevant law provisions, and requesting the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred, Objecting to a result against you by analyzing the processed data exclusively through automated systems, Claiming compensation for the damage arising from the unlawful processing of your personal data.

You can submit your applications regarding your rights listed in Article 11 of the KVKK above to "**TAMEK**" by filling out the **Data Subject Application Form**, which you can access on our website with the extension (**www.tamek.com.tr**), or with another written document with the same content.

Depending on the nature of your request, your applications will be concluded free of charge as soon as possible and within thirty days at the latest, however, if the process requires an additional cost, you may be charged a fee according to the tariff to be
